# A. Treasurer Report (Finance/Budget):

- **Receipts** \$400 voluntary bridge fund payments.

- **DEP/Quality** TTHM results from last months sampling were extremely low (and low is good). The latest quarterly reading of 23ppb brings our annual average down to 44ppb (the limit is 80 ppb). We attribute these lower readings to additional flushing on East Street and changes in water distribution by the City of Fitchburg.
