

# <u>Leino Park Water District</u> (LPWD) Board of Commissioners' Meeting - October 1, 2014

- **1. Call to Order**: October 1, 2014 at 7:05 pm
  - **Members present**: Sue Miller (SM), Dave Crumbley (DC), Bob Marien (BM), Don Williams (DW), and Derek Knerr (DK).
  - Guests present: None.
- **2. Review and Approve Minutes**: Minutes from our August 6th and September 3rd meetings were not available for approval.

## 3. Reports:

# A. Treasurer Report (Finance/Budget):

- **Receipts** \$216.70 for water payments.
- Expenditures \$733.07 for water testing, utilities, postage and supplies.
- **Budget** No update.
- **Billing** One household paid their water bill so only 4 late payment notices will be sent out next week.
- Other Shortly after our last meeting, DC sent in the information previously requested by the USDA. DC reported that a lightning strike damaged the Leino Park Water District computer and printer. Replacement equipment was purchased and DC will check to see if his homeowners insurance will cover this loss.

## **B.** Water System Operator's Report:

- Maintenance of lines and meters Two customers have contacted us to have their meters removed for the winter. DC inspected the curb stop (not a blow off valve) at the south end of Old Oak Ave. Curb stops have adjustable shafts (similar to an automobile antennae) so it should be fairly easy to (have BB) tap it down.
- DEP/Quality TTHM samples taken last in August came back well within acceptable limits.
- Water System Operator Training Nothing new to report.

## C. Maintenance Report:

- **Bridge** Still there...
- Roads We have received several requests to remove speed bumps, especially the new one.

### D. Bridge Report:

- **Replacement options** Nothing to report.
- **Replacement funding** DK reported that he spoke with Steve at USDA. The loan application process is proceeding slowly.
