

## <u>Leino Park Water District</u> (LPWD) Board of Commissioners' Meeting – January 4, 2023

- 1. Call to Order: January 4, 2023 at 7:05pm
  - Members present: Chairperson: Elizabeth Williams (EW); Water Commissioner: Bob Brown (BB);
     Treasurer: Derek Knerr (DK); Clerk/Moderator: Amie Robillard (AR).
  - **Guest(s)**: Darrel Hopkins
- 2. Review and Approve Minutes: Meeting minutes from Dec 7, 2022 were approved as distributed.

#### 3. Reports -

### A. Treasurer Report (Finance/Budget):

- **Receipts** \$294.39 received. Income includes water payment and late fee (\$78.05), repayment of a water meter (\$201.19), and interest (\$15.15).
- Expenditures \$1,124,900.11 paid out. Expenses include an interim financing payment (\$1,111,572.11), wired bank charge (\$25), McCarty engineering December invoice (\$1402.43), legal fees (\$11,593.50), park utilities (\$46.77), water testing (\$224), salaries (\$83.34), mileage reimbursement (\$26.66), road maintenance and supplies (\$11.63), office expenses (\$31.86) and postage (\$84.00).
- **Billing** Invoices for water used between July 1 and Dec 31, 2022 were mailed to with a due date of Jan 31, 2023.
- Other DK will continue to look into the District becoming tax exempt.
- DK provided a detailed Year-End review of the financial balance sheet.
- For those who wish to make a one-time payoff of their loan obligation, the District intends to
  deposit the money received into a high interest long-term savings account. DK has researched
  and found that Salem Five Bank is currently offering 3.5+%. All are in favor of opening an
  account.
- Payment from Wyman Lake Association has been issued and is expected to be received by the District this month. Money will be deposited into long-term savings account.

#### B. Water System Operator's Report: DC not in attendance

- Maintenance of Lines and Meters water samples to be taken Tuesday, Jan 10<sup>th</sup>.
- The board is actively seeking a new Water System Operator. This is a paid position. Anyone

#### C. Maintenance Report:

- **Bridge** BB had added reflectors to the end of the bridge.
- Signs for under the bridge will be added: no wake zone and no jumping.
- Despres Landscaping & Excavation is plowing our bridge with a rubber blade. You may see their equipment stored on Leino Park Rd.
- Outdoor video surveillance for the bridge will be explored and considered as a future expense.
- Roads boulders, or a barrier of some kind, is needed along the right on Leino Park road as you approach the bridge. Town DPW has still not been able to assist with this need and indicates they will remain in communication with DK if any boulders should be located.
